Selecting the right ITAD vendor starts with clearly understanding your organization's needs. Because vendor capabilities vary widely, use a mix of research methods to build a shortlist including: directories, associations, and industry conferences. A well-aligned partner should meet compliance expectations while supporting long-term ROI and ESG performance.



Analyst Reports

- Gartner Market Guides for ITAD or Circular IT (note: limited in depth, but often cited).
- Forrester Wave reports may touch on relevant adjacent markets (ESG, device lifecycle, secure logistics).
- Verdantix (ESG focus) publishes on sustainability in IT procurement and vendor evaluation.
- Frost & Sullivan or Everest Group can provide paid ITAD market assessments or maturity frameworks.

- ProcureCon IT Sourcing Broader IT vendor sourcing strategies with growing ITAD relevance.
- IT Procurement Summit Focused on new technologies and market changes in the IT procurement industry.
- HIMSS: Industry conference focused on emerging technology in the healthcare field.
- GreenBiz Circularity Conference Strong ESG and sustainability strategy content.

- <u>SERI</u> Oversees the R2 certification program and provides a global list of certified ITAD vendors committed to safe and sustainable e-waste handling.
